

TERMS AND CONDITIONS FOR THE "NEWSLETTER" SERVICE

Art.1 General Provisions

1. These regulations set out the terms and conditions for the provision of the free "Newsletter" service, hereinafter referred to as the "Service".
2. The service is provided by ELECTROSMART WĘGRZYN SPÓŁKA KOMANDYTOWA with its registered office at ul. Polonijna 23/U1, 30-668 Kraków, NIP: 6793204047, entered into the National Court Register under number: 0000855964, hereinafter referred to as the "Seller".
3. The "Newsletter" service consists in sending information about the current activities of the Seller or commercial information concerning the Seller's activities via electronic mail to the e-mail address provided by the Customer.

Art.2 Terms of service

1. The Newsletter service is free of charge.
2. The condition for using the service is providing an e-mail address to which the Newsletter is to be sent, and giving consent to this service, as well as consent to receiving commercial information via e-mail and to the Newsletter service regulations.
3. The use of the Newsletter service is subject to fulfilment of the same technical conditions that are stipulated for use of the Store.
4. The use of the Newsletter service may involve the standard risks associated with the use of the Internet. It is advisable to take appropriate steps to limit it, such as using antivirus software with an up-to-date virus database and firewall software, as well as legal e-mail software.
5. When using the Newsletter service, the Customer is obliged to refrain from supplying unlawful content.

Artr. 3 Commencement of service and complaints

1. To register in the Newsletter database, the Customer provides his/her e-mail address, accepts the terms and conditions of personal data processing and the Terms of Service and selects the "Subscribe" button.
2. Provisions concerning the protection of personal data processed in connection with the Newsletter service have been included in "ELECTROSMART Privacy Policy" available for review on the Company's website (<https://electrosmart.pl/polityka-prywatnosci-rodo-2>) and directly with the Seller.

3. Signing up for the Newsletter shall be confirmed by an email sent to the Customer, which is equivalent to concluding a Newsletter service agreement.
4. When using the Newsletter service, the Customer is obliged to refrain from supplying unlawful content.
5. Complaints concerning the Newsletter service can be submitted in the same way as complaints in the Store.

Art. 4
Duration of service

1. The service is provided for an indefinite period of time, until the contract is terminated by the Customer or the Seller.
2. Termination shall not require any justification and shall happen immediately.
3. The User may unsubscribe from the Newsletter service at any time, without giving reasons and without incurring costs, by clicking on the link at the footer of each Newsletter.
4. The Seller may suspend or terminate the Newsletter service upon prior notification to the User.
5. The Seller has the right to delete an incorrect or non-existent e-mail address provided by the Customer.
